### <u>Secretary's Report – Ed Kelb</u>

# <u>Treasurer's Report – Kelly Dixon</u>

- Refer to full reports online.
- The Treasurer deposited \$5310 in Dues payments in March/April for 2020 and \$5 to make up for a shortage from last year that an owner didn't know about.
- We had 6 more payments sent in based upon the April Newsletter "list of paid members" for a revised total of 385 homes. That's 74.9% FECA participation for 2020!
- The Treasurer deposited \$350 in Special Events Donations from two residents. Because we couldn't proceed with the Spring Fling (Florida Covid-19 Quarantine measures), we should be able to have great events this fall/winter if we choose to.
- Needed to place an order for checks (not budgeted for 2020). The last box of checks lasted 4
  years so FECA should be set for a few years.
- Directory ad sales were deposited as a credit against the printing cost. Still had plenty of bags so there was no need to order new ones; therefore, we are under budget on the overall cost of the Directory.
- The balance of the Palm Blvd Signage was paid.
- The Treasurer bought enough stamps for the April Newsletter and the Fall Newsletter. The number of hardcopies we mail dropped again by another 5-10 as we obtain more and more email addresses. Tabs were needed to seal the Newsletters. The Treasurer purchased a large bulk order that should carry over for a few years. \$2 over budget for the year for tabs ... but FECA won't need labels so we should stay under budget as a whole for the Newsletters.
- Routine Lawn, Lake and Utilities were paid

### **Old Business:**

# **Speeding and Traffic Violations in FE:**

 Given the measures currently in place regarding Covid-19 quarantining and related matters, police personnel have been temporarily assigned to other functions. There is no active monitoring in FE at this time; however, we hope that this will regain some traction as the pandemic subsides.

# Resident Feedback regarding the new sign at Palm Blvd and Burke Ave:

- Residents (and some FECA Board members) feel that the text lettering on the sign is not level.
  - o Is this a result of the monument itself not being level?
  - o Is there an error with the text in the new signs?
  - Other cause?
- Derrick Beland is going to follow-up with a series of measurements to see if we can better determine the actual problem. Results to be reviewed at the next FECA Board Meeting.

# Repair / Replacement of Lights for Palm Blvd monuments:

- Please refer to Exhibit A for a summary of the problem (as reviewed in the March 2020 FECA Board Meeting)
- Three LED Lamps ordered for evaluation:
  - The first LED lamps I received are cheaply made (plastic) and will not be considered for installation
  - One set of lamps scheduled for delivery around May 20<sup>th</sup>
  - One set of lamps that was ordered had its status changed to "backordered"
- Depending of quality of lamps delivered May 20<sup>th</sup>, I may install one to see if it can address our concerns.
- If I have multiple lamps arrive in time, we will attempt to setup a test where
  residents can view different options. The challenge being that Amazon only
  provides me a 30 day window for returns ... so the backordered lamp is creating a
  timing issue.

### **New Business:**

### 2020 - 2021 Resident Directories:

- Delivery of Directories to FE resident doors was postponed when quarantine
  measures went into place, however, we need to bear in mind that advertisers have
  paid for space in the directory. Now that Florida has begun a phased approach to
  reduce quarantine restrictions, we should begin delivery of the directories as soon
  as possible.
  - Note: It isn't a desirable scenario to leave a directory hanging on a doorknob for seasonal residents who have already returned to their northern homes.
     The FECA Board will do its best to avoid delivery for these residents, the obvious challenge being identification of those residents.

# FECA and Usage of Social Media:

- From a legal standpoint, FECA needed to make it clear that social media platforms like Facebook, Nextdoor, Twitter, etc. are unofficial and not sanctioned by FECA. These media are only used for social purposes.
- <u>www.fairwayestates.org</u> is the <u>ONLY</u> officially sanctioned website for FECA.
- Internet domain fairwayestates.org is the <u>ONLY</u> officially sanctioned E-Mail source for communication.
- The official FECA website as well as social media groups on both Facebook and Nextdoor have had their descriptions altered to clarify this for all users.


#### **EXHIBIT A**

### Issues with Replacement LED Lamps on Palm Blvd

Original Fluorescent Lighting: 13 watts 800 Lumens (aka brightness)


Replacement LED Lights: 15 watts 1663 Lumens (108% brighter than original light)

Lack of GLARE GUARDS (blocks extraneous light) & doubling of brightness not well received by residents.



# **Existing Challenges:**

- 1) Lighting is 108% brighter
- 2) Existing LED lights do not have Glare Guards. Beam Angle is 104 degrees resulting in some direct lighting aimed toward resident's homes and vehicles driving on Palm Blvd.



#### **Board Recommendation:**

- 1) Purchase two or three replacement lamps for evaluation:
  - LED lights with Glare Guards
  - Brightness: 600 800 Lumens
- 2) Setup test scenario after dark so adjacent neighbors can participate in selection process
- 3) Install selected replacement lamp on both monuments return other lamps for refund
