Secretary's Report – Ed Kelb

- Motion made to accept **Dec 2019 FECA Board Meeting** minutes (submitted on January 8, 2020 at 3:40pm) "as written" by Kelly Dixon, 2nd by Bill Greenwood. Motion carried.

<u>Treasurer's Report – Kelly Dixon</u>

- Refer to full reports online.
- A banking error occurred where a \$213 deposit intended for Kelly Dixon's personal bank account was credited to the FECA bank account. Request from Kelly Dixon to reimburse herself from the FECA account.
 - Motion made to reimburse Kelly Dixon \$213 by Ed Kelb, 2nd by Marilyn Parnell. Motion carried.

- 2019 Holiday Party (Dec) expenses were over budget; however, we had a surplus carried over from an earlier sponsorship. Therefore, this did not impact the total budgeted expenses for annual events.
- Motion made to accept Jan 2020 FECA Treasurers Report "as written" by Todd Brooks, 2nd by Ed Kelb. Motion carried.
- Proposed 2020 Annual Budget comments/revisions:
 - Annual Dues Estimates: 355 households x \$45 = \$15,975
 - Lake Saundra water maintenance has been previously performed by *Aquatics Systems* Lake and Wetland Services. The company is now known as SOLitude Lake Management. Ref: <u>https://www.solitudelakemanagement.com</u>
 - Price will be increasing from \$95 per month to \$98 per month.
 - The revised reports from SOLitude Lake Management do not appear to contain the level of detail that was provided by Aquatics Systems Lake and Wetland Services. See Exhibit A. Examples from report:

President's Report – Matt Stevens

- Chuck and Ken (*Dunedin Golf Club* General Manager) approached Matt to see if they could engage the FECA Board with the intent of brainstorming ways of improving and encouraging both communication and utilization of the *Dunedin Golf Club* by Fairway Estates residents.
- Positive feedback from President Matt Stevens that the tree maintenance performed in 2019 is already showing some benefits. A storm front with high winds moved through the area and left far fewer dead limbs and debris (versus what has been seen in the past).
- An observation from Matt that there is some aggressive plant growth along the northwest shoreline of Lake Saundra. Some variation of climbing vines that are moving into the grassy area. FECA Board members encouraged to take a look and determine if this is an invasive species that should be addressed before it become problematic.
- Lock on Lake Saundra *Dog Waste Bag Unit* is rusted and needs replacement. Matt Stevens will take this on as an action item.

• 2020 Annual Homeowners Meeting

Old Business:

• 2019 Entrance Signs Project Update:

- Refer to **Exhibit B** for details
- Monuments will require that existing paint be power washed to remove as much as possible. Current paint is chipping and bubbling. New signs will not adhere properly.
- As this will need to be done, the FECA Board has decided to have the white concrete topper power washed and painted as well.
- Proposed sequence of events:
 - Wait for USA Signs, Inc to contact FECA once the new signs are ready to be installed (Feb, 2020).
 - Utilizing either a professional painter or a FECA volunteer, have both Palm Blvd monuments completely prepped:
 - Power wash and scrape old paint (both green and white paint)
 - Repaint (white paint) concrete topper over sign and concrete pineapple post finials.
 - Repaint reverse side of monument (dark green) that faces the corner resident home
 - Schedule USA Signs, to install new signage.



<u>Memory Walk</u>

- The FECA Board is looking at ways to fund a replacement sign in 2021. A **Memorial Walk** <u>might</u> be a viable candidate to raise funds to replace the sign in 2021.
- A **Memorial Walk** would be a way for residents of FE to memorialize family and events by engraving a paver with a customized memorial. See **Exhibit C** for an example design. Note: This is just one of many possibilities.
 - Note: These pavers would not be available to vendors. The intent is to provide residents a way to recognize:
 - Residents
 - Resident Families
 - Pets
 - Birthdays, Anniversaries, Weddings
 - Passings
 - Other Milestones

for <u>residents</u> who have ties to Fairway Estates.

- Depending on resident interest, we could install a walkway to the sign ... or install a brick walkway to surround the existing Lake Saundra sign.
- Residents could choose from either an 8" x 8" paver or a 4" x 8" paver. Examples of engraved pavers can be found in front of the Dunedin Golf Club.
- The FECA Board would retain "First Right of Refusal" to ensure that any engravings are appropriate for the *Memory Walk*.
- Note: Because the existing Lake Saundra sign is located 14 feet from the curb, there does not appear to be any supplemental City of Dunedin funding available to replace the Lake Saundra sign (e.g. the sign is owned by FECA and is not eligible for City of Dunedin funding).

- 1/2" PVC dimensional letters painted face & edges

December 12, 2019- **site meeting with Signs USA (Tom Miano, VP)** to view site and discuss project

December 16, 2019- site meeting with Signs USA to **measure monuments** (VP & Joe Muhrlin, Production Mgr)

January 2, 2020 - **initial layout received** from Signs USA; returned with comments

January 7, 2020- **updated layout received** from Signs USA; layout accepted; **project moves into production** 3-4 week timeline for production & install

January 8, 2020- site meeting with Signs USA VP to **check fit of initial templates ;** adjustments needed to both templates . New templates will be created and follow up visit will be made to check fit before proceeding (this process will be repeated until satisfactory template is created)

Monument Preparation

Action Item(s)

Power wash/scrape surface of monuments to remove bubbles (panel adheres better)

- * Remove existing letters, fill holes & assure smooth surface
- Power/wash then paint white trim; suggested- paint back of monuments (dark green)
- Beautification to tidy landscaping & provide new plantings
