#### <u> Treasurer's Report – Kelly Dixon</u>

- We remain at **385 houses paid** 74.9% participation.
- Routine Lawn, Lake and Utilities were paid.
- FECA website hosting renewal was paid.
- The FECA Treasurer noted that it is acceptable to move surplus funding from the cancelled 2020 social events into the FECA Reserve/Contingency fund for later use. This would provide the FECA Board additional time to review alternatives discussed in earlier meetings (possibly replace Lake Saundra signage, 2<sup>nd</sup> picnic table, etc.)
- Motion made by Mary Lyon to accept the Oct 2020 FECA Treasurer report "as written". 2<sup>nd</sup> by Derrick Beland. Motion carried.
- 2021 Preliminary Budget Review:
  - FECA Treasurer is **soliciting supplemental bids** to determine whether we can decrease insurance expenses from either of the two companies we currently use.
  - o 2021 budget estimating that 379 homes will participate (73.7%)
  - Supplemental budgeting included for the possibility of Lake Saundra Signage replacement or a 2<sup>nd</sup> picnic table.

- Financial consideration factored into the possibility of moving the *Annual Homeowners Meeting* to Monday in 2021. While this would add some additional expense, it would provide for social distancing as the dining room is not typically open on Mondays.
- Observation from President Matt Stevens that **Covid-19** <u>unknowns</u> (lockdowns, quarantines, potential lack of additional stimulus) ... could impact 2021 dues collected.


